  - ESDHD Financial Advisor Updated Fund Recommendations Postponed until after the election.
  - Climate Change Photojournalism Project/Interns Status National Environmental Health Association (NEHA) Summer Internship Grant Proposal – Status – UCONN MPH student to continue the project for another year and continue for an independent study. APHA accepted the abstract and project will be presented in Boston in November.
  - National Silva Presidents Award Director presented last month, received some media attention. The state is putting out a press release in the next week or two.
  - Epic Clinical Data Base Director reports that we have hit a glitch, tabled at this time.
  - Health Department file digitation project Research has continued reviewing
    other health districts programs was recently done. We have selected a vendor and
    the project is moving on track. Over the next year, we will be scanning files after
    they are scrubbed. Hoping to have most of it in the first year. Some of the work
    will be done in-house to be sure scanning is appropriate after scanning to post,
    especially with the new changes in the long and certain documents are no longer
    public knowledge.

## 5. New Business

- Board meeting calendar discussion discussion on changing the time and day.
   Proposal to change meeting time to 3:30 p.m. on Thursdays for trial the new time for one year to begin next month. All agreed to the new change.
- CT DPH Opioid Grant Award \$80,000 award given to ESDHD for the next two years (\$40,000 each year), back dates from September. Grant entails meeting one on one with physicians in the community to discuss prescribing opioids. Educating them about the new laws around prescribing and reducing the number of prescriptions related to the opioid crises. Received past grant and program was successful, will help build relationships with physicians and practices. Hope to receive additional grants in this area.
- ESDHD/Yale publication has been accepted to the Journal of Environmental Health to be published in December 2022.
- Flu vaccine update given by Director have 40 clinics scheduled throughout the district and beyond, and through corporate wellness for private clinics. ~2,000 vaccines are expected to be given.
- Introduction of a new Epidemiologist; Madison Wierzel. She will present Coronavirus update.
- Coronavirus Update Local & State Update Presentation by Madison Wierzel -Coronavirus Update / Vaccination Statistics – Local & State Update Presentation from the Director. He reviewed national statistics, the statistical trending/chart of Connecticut. Madison reviewed weekly reports, monthly for all three towns in the district including, positivity rates, age distribution, fatalities, vaccination and booster rates, trends. A review of vaccines, staff positives, school cases, daycares, and hospitalization status for the district. Reviewed takeaways. Discussed why individuals are not getting vaccinated due to miss information.
